DISTINGUISHING FEATURES OF THE CLASS: This is the first level of the Water Plant series and is responsible for performing basic and directed activities of monitoring water production and chemical levels, conducting basic lab tests, and performing assigned housekeeping activities. The incumbent does related work as required.

EXAMPLES OF WORK ACTIVITIES: (Illustrative only)

- Performs routine maintenance work on the filter plant facility, which includes: performing filter backwashes; oiling, greasing, cleaning, painting, and calibrating water treatment equipment; emptying and changing chlorine tanks; and/or, performing other related activities.
- Performs laboratory tests under direction of senior staff, including turbidity, chlorine residual, and pH testing; calibrates lab equipment for proper lab results.
- Performs maintenance of building and grounds as assigned, including operation of mowers, chain saws, snow removal equipment, and painting supplies.
- Reads meters to determine and document chemical levels and water usage.
- Maintains and updates log books; records reading of meters, gauges, and scales according to federal and state guidelines.
