FILING FEE: \$15.00 non-refundable fee. Cash or check or money order payable to City Comptroller accepted. Include examination

number on your check. <u>Credit cards are ACCEPTED ONLINE ONLY</u>. See general instructions regarding exceptions to the fee requirement. Applicants whose personal checks are returned for insufficient funds will be charged an additional fee.

LAST FILING DATE: Applications must be received no later than 11:59 PM Sunday, April 28, 2024

VACANCIES: The eligible list resulting from this examination will be used to fill appropriate vacancies as they occur in the City of

Watertown.

SALARY: \$66,496 - \$83,851

MINIMUM QUALIFICATIONS: Either

(A) Graduation from a regionally accredited college or university or one accredited by the NYS Board of Regents to grant degrees with a Bachelor's Degree or higher in mathematics, accounting, business, economics, public administration, science, or closely related field and 4 years of full-time paid experience as an assessor, appraiser, valuation data manager, or similar experience; or

- (B) Associate's Degree in mathematics, accounting, business, economics, public administration, science, or closely related field and 6 years of full-time paid experience as an assessor, appraiser, valuation data manager, or similar experience; or
- (C) Graduation from high school or possession of a high school equivalency diploma and 8 years of full-time paid experience as an assessor.

DRIVER'S LICENSE REQUIREMENT- Must possess and maintain a valid NYS Driver's License.

SPECIAL REQUIREMENT: Must obtain and maintain certification as a sole appointed assessor as required by New York State.

DUTIES: Responsibilities include developing valuation methodologies and procedures; inspecting properties; preparing reports; planning and managing special projects; and responding to questions, complaints and issues from the public.

SUBJECT OF EXAMINATION: A test designed to evaluate knowledge, skills and /or abilities in the following areas:

<u>Preparing written material</u>- These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.

- Administrative techniques and practicesThese questions test for a knowledge of management techniques and practices used in
 directing or assisting in directing a program component or an organizational segment. Questions cover such areas as interpreting policies,
 making decisions based on the context of the position in the organization, coordinating programs or projects, communicating with
 employees or the public, planning employee training, and researching and evaluating areas of concern.
- <u>Supervision</u> These questions test for knowledge of the principles and practices employed in planning, organizing, and controlling the activities of a work unit toward predetermined objectives. The concepts covered, usually in a situational question format, include such topics as assigning and reviewing work; evaluating performance; maintaining work standards; motivating and developing subordinates; implementing procedural change; increasing efficiency; and dealing with problems of absenteeism, morale, and discipline.
- <u>Understanding and interpreting Real Property Tax Law</u> These questions test for the ability to read, interpret and apply the New York
 State Real Property Tax Law. You will be provided with brief reading selections based on or taken from the New York State Real Property
 Tax Law, followed by one or more questions. All the information needed to answer the questions is contained in the reading selections. No
 prior knowledge of the subject is required.
- Real property acquisition, appraisal, negotiations, relocation, property management and applicable state and federal laws, rules and regulations These questions test for knowledge of terms, principles and processes relating to the State of New York's ability to acquire and sell real property. They cover such subjects as the role of negotiators in real property acquisition; right of landowners and tenants when the State acquires property; factors influencing property value determinations and rent determinations; types and characteristics of leasing agreements; eligibility for relocation payments and calculation of payment amounts; and management of State property as an asset, including disposition. The information needed to answer some of these questions can be found in the Eminent Domain Procedure Law, Environmental Conservation Law, Public Lands Law and State Highway Law.

The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information in the publication 'General Guide to Written Tests' helpful in preparing for this test. USE OF CALCULATORS: Calculators are recommended for this exam.

HOW TO APPLY: Applications may be obtained from and must be filed at the Watertown Civil Service Commission, Room 205 Municipal Building, 245 Washington Street, Watertown, New York. Applicants must answer every question on the application and make sure it is complete in all respects. Incomplete applications will be disapproved. Falsification of any part of the application will result in disqualification. <u>Education and work experience must be documented on the application regardless if the candidate has elected to attach a resume.</u> All statements made by candidates in their applications are subject to verification. Applications <u>will not be</u> accepted past the last filing date of the examination.

APPLICATION FEE: If your application is disapproved, the fee will not be refunded. You should carefully review the announced minimum qualifications. Please make sure you meet the minimum qualifications before applying to any examination. Applicants whose personal checks are returned for insufficient funds will be charged an additional fee.

VETERANS' CREDIT: Veterans or disabled veterans who are eligible for additional credit must submit an application for veterans' credit available from the Civil Service Commission. Applications for veterans' credit may be submitted with your application for examination or at any time before the new eligible list is established. Candidates currently serving in the armed forces may apply for conditional veterans' credits in examinations. Candidates who apply for such credit must provide proof of military status. It is the responsibility of the candidate to provide appropriate documentary proof indicating that the service was in time of war, as defined in Section 85 of the New York State Civil Service Law, and that the candidate received an honorable discharge or was released under honorable conditions. No credit may be granted after the new eligible list is established.

SPECIAL TEST DATE ACCOMMODATIONS/SABATH OBSERVERS/DISABLED CANDIDATES/MILITARY MEMBERS: Applicants whose religious beliefs or military service prevent their taking examinations on the scheduled date and disabled candidates who require special accommodations to take the test should indicate the need for special arrangements on their application. Candidates who are called to military service after filing an application should send requests for an alternate test date to the Watertown Civil Service Commission as soon as possible before the test date. Please see back of application for further information and instruction.

MULTIPLE EXAMINATIONS SCHEDULED FOR THE SAME DAY: If you have applied for any other civil service examinations to be given on the same test date for employment with New York State or any other local government jurisdiction excluding New York City, you must make arrangements to take all the examinations at one test site. If you have applied for both State and local government examinations, you must take all your examinations at the State examination center. Please complete the Cross Filing form located on the City's website and submit it with your application, include all exams for which you have applied and at which agency you wish to take the exams. Your request must be received by this office no later than three (3) weeks before the date of the examinations. Requests received less than three (3) weeks before the date of the examinations will NOT be honored.

ADMISSION TO EXAMINATION: The Watertown Civil Service Commission does not acknowledge receipt of applications but all applicants are notified of the disposition of their application. <u>Approved candidates will be notified at least five days in advance of the examination of the place, date and hour of the examination.</u>

RATINGS REQUIRED: Unless the announcement states otherwise, this examination is being prepared and rated in accordance with Section 23(2) of the Civil Service Law. The provisions of the New York State Civil Service Laws, Rules and Regulations dealing with the preparation and rating of examinations, as well as establishment and certification of eligible lists for positions in the classified service will apply to this examination.

ELIGIBLE LIST: The duration of the eligible list may be fixed for a minimum period of one (1) year up to a maximum period of four (4) years. As employment opportunities arise, appointments from the eligible list will be made from the top three candidates willing to accept appointment.
